RESOLUTION NO. 1289

A RESOLUTION in regard to L.I.D. No. 59-S-13 for the improvement of 106th Avenue N.E.; and authorizing payment of interest, attorney fees, and other miscellaneous expenses.

WHEREAS the City Council did on May 24, 1960, pass Ordinance No. 359, thereafter amended on May 7, 1963 by Ordinance No. 593, and by the court's ruling in Sterling Realty Co. v. The City of Bellevue, for the improvement of 106th Avenue N.E. between Main Street and N.E. 8th Street, by paving and otherwise improving the same, and did create Local Improvement District No. 59-3-13 therefor; and
