RESOLUTION NO. 1318

A RESOLUTION regarding the annexation of contiguous unincorporated territory, lying southerly of the Bellevue-Redmond Road and easterly of the existing City limits; and amending Resolution No. 1316.

WHEREAS the City Council did on March 7, 1967, pass Resolution No. 1316, which prayed the Board of County Commissioners of King County, Washington, to call an election upon the question of whether or not the following-described area should be annexed to the City of Bellevue:

A portion of Sections 28, 33 and 34, Township 25 North, Range 5 East, W.M., described as follows:

Beginning at the intersection of the Bellevue City Limits, as established by Ordinance 676 of the City of Bellevue, passed August 11, 1964, and the east line of the West  $\frac{1}{2}$  of the West  $\frac{1}{2}$  of Section 34; Thence northerly along said east line to the southerly margin of N.E. 8th Street;

Thence westerly along said margin to the west line of Section 34; Thence northerly along said west section line to the southeast corner of Section 28;

Thence northerly along the east line of said Section 28, to the existing Bellevue City Limits;

Thence northerly, southwesterly, southerly, westerly, southerly, westerly, southerly, westerly, southerly, and easterly along the existing Bellevue City Limits to the point of beginning.

Situate in King County, Washington.

AND WHEREAS the Review Board convened by the Mayor to hear and consider said question did delete certain property from the area under consideration, and it is felt desirable to amend the original resolution to conform to the area as approved by the Review Board; now therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. Section 1 of Resolution No. 1316, passed March 7, 1967, is hereby amended to read as follows:

Section 1. The City Council does hereby determine that the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory, which is contiguous to the City of Bellevue:

A portion of Sections 28 and 33, Township 25 North, Range 5 East, W.M., King County, Washington, described as follows:

Beginning at a point on the existing City Limits of the City of Bellevue, as established by Ordinance 676 of August 11, 1964, said point being more particularly described as the southwest corner of the south  $\frac{3}{4}$  of the east  $\frac{1}{2}$  of the Southeast  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of Section 33; Thence northerly along the west line of said  $\frac{3}{4}$  to the north line thereof; Thence easterly along said north line

to the east line of said Section 33; Thence northerly along said east section line and continuing along the east line of Section 28 to the south line of that area annexed to the City of Bellevue on April 9, 1964, described in Ordinance 646; Thence along the existing City Limits of the City of Bellevue northerly, southwesterly, southerly, westerly, southerly, westerly, southerly, westerly, southerly and easterly to the point of beginning.

Section 2. Section 2 of Resolution No. 1316, is hereby amended to read as follows:

Section 2. That, as nearly as may be, the number of voters residing in the aforesaid territory is 623.

Section 3. That a certified copy of this amendatory resolution be filed with the Board of County Commissioners of King County, Washington, in which county said territory is located.
