RESOLUTION NO. 1326

A RESOLUTION regarding the annexation of contiguous unincorporated territory, lying generally between N.E. 24th, N.E. 70th, 116th N.E. and 148th N.E., and commonly referred to as the "Bridle Trails Annexation."

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The City Council does hereby determine that the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory which is contiguous to the City of Bellevue:

Portions of Sections 9, 10, 11, 14, 15, 16, 21, 22 and 23, Township 25 North, Range 5 East, W.M., King County, Washington, described as follows:

Beginning at the intersection of the east line of Section 21 and the north line of N.E. 24th Street;

Thence easterly along said north line to the east line of the SW_{4}^{1} of SW_{4}^{1} of Section 22;

Thence northerly along said east line to the north line of S_2^1 of the S_2^1 of the S_2^1 of said Section;

Thence easterly along said north line to the east line of 148th Ave. N.E.;

Thence northerly along said east line to the easterly extension of the south line of Section 10;

Thence westerly along said extension and along said south line to the east line of the W_2^1 of the SW_4^1 of said Section 10;

Thence northerly along said east line to the southerly line of Collins Road;

Thence westerly along said southerly line to the west line of the plat of Burke & Farrars Kirkland Addn. Div. 20;

Thence southerly along said west line to the north line of the plat of Silver Spurs Ranch No. 2;

Thence westerly to the eastern City Limits of Houghton;

Thence southerly and westerly along said City Limits to the west line of the Northeast $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ of Section 16;

Thence southerly along said west line and easterly along the southerly line of said Northeast $\frac{1}{4}$ of the Northwest $\frac{1}{4}$ and continuing easterly along the south line of the Northwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 16 to the east line of said Northwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$

Thence northerly along said east line to the south line of N.E. 60th Street;

Thence easterly along said south line to the west line of 132nd Ave. N.E.;

Thence southerly along said west line to the north line of Section 21;

Thence westerly along said north line to the City Limits of Bellevue;

Thence southerly, easterly, southerly, easterly, and southerly along said existing City Limits to the north line of N.E. 24th St and the point of beginning; Less portion previously annexed under Ord. 903, dated July 5, 1966.

Section 2. That, as nearly as may be, the number of voters residing in the aforesaid territory is 724

Section 3. That, in the event the electors approve the annexation, the territory so annexed will not be assessed or taxed to pay for any outstanding indebtedness of the City of Bellevue contracted prior to, or existing at, the date of annexation.

Section 4. That, in the event the electors approve the annexation, simultaneous therewith a community municipal corporation be created, the service area of which shall be that described in Section 1 above, and council members elected, all as provided for in House Bill No. 115, Laws of 1967. Further, that the proposition for the creation of a community municipal corporation be submitted to the electorate as a separate proposition.

Section 5. The City Council does hereby pray that the Board of County Commissioners of King County, Washington, call an election to be held among the qualified voters of the aforesaid territory upon the question of annexation, and upon the question of the creation of a community municipal corporation, and that the voters cast ballots for candidates for positions on the council.

Section 6. That the cost of said annexation election shall be paid by the City of Bellevue.

Section 7. That a certified copy of this resolution be filed with the Board of County Commissioners of King County, Washington, in which county said territory is located.
