RESOLUTION NO. 1336

A RESOLUTION in regard to L.I.D. No. 66-SAN-91 for the construction of sanitary sewers within an area generally described as bounded by 130th N.E., 140th N.E., Northrup Road and Bellevue-Redmond Road; and amending Resolution No. 1331, which authorized payment of a draw to the contractor and other miscellaneous expenses.

WHEREAS the City Council did on July 19, 1966, pass Ordinance No. 913 for the improvement of an area generally described as bounded by 130th N.E., 140th N.E., Northrup Road and Bellevue-Redmond Road, by the construction of sanitary sewers, and did create Local Improvement District 66-SAN-91 therefor; and

WHEREAS said project has progressed and L.I.D. revenue warrants have previously been issued as follows:

Warrant No. 2, dated October 10, 1966	8,829.60
Warrant No. 3, dated October 27, 1966	14,597.68
Warrant No. 4, dated November 21, 1966	35,279.51

Warrant No. 7, dated March 28, 1967	18,140.43

AND WHEREAS a contract has been let for the construction of the above-entitled public works project, and the Director of Public Works has, in writing and under the date of May 2, 1967, approved and recommended payment to Eerkes Construction Co., Inc., of the sum of \$5,679.13, although Resolution No. 1331 inadvertently stated that the Director of Public Works had, in writing and under date of March 21, 1967, also approved and recommended payment to Eerkes Construction Co., Inc., of the sum of \$16,533.61;

AND WHEREAS additional costs have accrued and claims have been presented by the following:

J. K. McLaughlin, engineering services, inspection	\$ 1,128.00
Michael Williams, surveying services	962.40

AND WHEREAS, it is necessary to issue L.I.D. warrants in payment thereof;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Bellevue, Washington, as follows:

Section 1. The resolving paragraph of Resolution No. 1331, passed May 9, 1967, is hereby amended to read as follows:

That the administrative personnel and proper officials, for and on behalf of the City of Bellevue, Washington, proceed with the issuance of Local Improvement District warrants in the amount of \$7,769.53, to bear interest in accordance with the bid and contract of Wm. P. Harper & Son & Company, contract purchaser of the warrants and bonds in the financing of said project.


