RESOLUTION NO. 1338

A RESOLUTION regarding the annexation of contiguous unincorporated territory, lying southerly and easterly of the existing City limits, and generally described as the Somerset-Monthaven area.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. That the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory which is contiguous to the City of Bellevue:

West 3/4 of Section 22, Township 24 North, Range 5 East;

South 1/2 of Section 15, Township 24 North, Range 5 East;

West 1/2 of N.E. 1/4 of Section 15 lying southerly of south margin
County Road No. 941;

Portion of N.W. 1/4 of Section 15 lying southerly and westerly of
following described line:

Beginning on east line of said subdivision at its intersection
with southerly margin County Road No. 941; thence westerly along
said margin to the southerly extension of west line of Tax Lot 32
of said Section; thence northerly along said extension and said
west line and along the northerly extension thereof to the north
margin of County Road No. 754; thence easterly along said north
margin to the west margin of 138th Avenue S.E; thence northerly
along said west margin to southerly margin of S.E. 40th Street;
thence westerly to the west line of the northeast 1/4 of the north-
west 1/4; thence northerly along said west line to the north line
of said Subdivision and the end of this line description;

Southwest 1/4 of Section 10, Township 24 North, Range 5 East, lying
southerly of the existing Bellevue City Limits EXCEPT the PLATS OF
EASTGATE DIVISION "K" and DIVISION "P";

Portion of North 1/2 of Southeast 1/4 of Section 10, Township 24
North, Range 5 East, lying southerly of existing Bellevue City
Limits and westerly of the east line of Tax Lot 54 and its north-
erly extension;

East 1/2 of Southeast 1/4 of said Section 22;

East 1/2 of Northeast 1/4 of Northeast 1/4 of Section 16, Township
24 N, Range 5 East.

Section 2. That, as nearly as may be, the number of voters residing in the aforesaid territory is 680.

Section 3. That the City Council does hereby pray that the Board of County Commissioners of King County, Washington, call an election to be held among the qualified voters in the aforesaid territory upon the question of annexation.

Section 4. That the cost of said annexation election shall be paid by the City of Bellevue.

Section 5. That the aforesaid territory if annexed, will not be required to assume the City's outstanding bonded indebtedness contracted prior to, or existing at, the date of annexation.

Section 6. That a certified copy of this resolution be filed with the Board of County Commissioners of King County, Washington, in which county said territory is located.
