RESOLUTION NO. 1341

A RESOLUTION in regard to L.I.D. 64-S-51 for the improvement of 100th Avenue N.E. from Main Street to N.E. 10th Street, and Main Street from 100th Avenue N.E. to 101st Avenue N.E.; and authorizing payment of draw to contractor and other miscellaneous expenses.

WHEREAS the City Council did on March 15, 1966, pass Ordinance No. 860 for the improvement of 100th Avenue N.E. from Main Street to N.E. 10th Street, and Main Street from 100th Avenue N.E. to 101st Avenue N.E., by paving and otherwise improving the same, and did create Local Improvement District No. 64-S-51 therefor; and

WHEREAS said project has progressed and L.I.D. revenue warrants have previously been issued as follows:

Warrant Nos. 41 through 45, dated November 21, 1966	4,405.38

AND WHEREAS a contract has been let for the construction of the above-entitled public works project, and the Director of Public Works has, in writing and under date of June 2, 1967, approved and recommended payment to Bass Construction, Inc., of the sum of \$23,516.32;

AND WHEREAS additional costs have accrued and claims have been presented by the following:

Botts Line, Inc., traffic buttons	\$ 625.20
J. S. Burnett and Son, installation of traffic buttons	118.35

AND WHEREAS it is necessary to issue L.I.D. warrants in payment thereof;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Bellevue, that the administrative personnel and proper officials, for and on behalf of the City of Bellevue, Washington, proceed with the issuance of local improvement district warrants in the amount of \$ 24,259.87, to bear interest in accordance with the bid and contract of Grande and Co., contract purchaser of the warrants and bonds in the financing of said project.
