RESOLUTION NO. 1351

A RESOLUTION regarding the annexation of contiguous unincorporated territory, generally described as the Somerset-Monthaven area; correcting the legal description thereof, and amending Resolution No. 1338.

WHEREAS the City Council did on June 6, 1967 pass Resolution No. 1338, finding that it would be to the best interests and general welfare of the City that a specifically-described area, generally known as Somerset-Monthaven, be annexed to the City, and did pray that the Board of County Commissioners of King County, Washington, call an election upon the question of such annexation; and

WHEREAS the legal description of the area proposed to be annexed did inadvertently contain certain reference lines which are not sufficiently definite to fulfill the legal requirements thereof; and

WHEREAS the review board which was convened for the purpose of determining whether said area was of such character that such annexation would be in the public interest and for the public welfare, and in the best interest of the City, County, and other political subdivisions affected, was able to and did consider the area actually intended to be proposed for annexation, did have maps before it for its use and consideration, and was not misled or confused by the use of the improper reference lines; now therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. Section 1 of Resolution No. 1338 is hereby amended to read as follows:

Section 1. That the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory which is contiguous to the City of Bellevue:

West 3/4 of Section 22, Township 24 North, Range 5 East;

South 1/2 of Section 15, Township 24 North, Range 5 East;

West 1/2 of N.E. 1/4 of Section 15 lying southerly of south margin County Road No. 941;

Portion of N.W. 1/4 of Section 15 lying southerly and westerly of following described line:

Beginning on east line of said subdivision at its intersection with southerly margin County Road No. 941; thence westerly along said margin to the center line of the Puget Sound Power and Light Co. transmission line easement; thence northerly along said centerline to the north margin of County Road No. 754; thence easterly along said north margin to the west margin of 138th Avenue S.E.; thence northerly along said west margin to southerly margin of S.E. 40th Street; thence westerly to the west line of the northeast 1/4 of the northwest 1/4; thence northerly along said west line to the north line of said Subdivision and the end of this line description;

Southwest 1/4 of Section 10, Township 24 North, Range 5 East, lying southerly of the existing Bellevue City Limits EXCEPT the PLATS OF EASTGATE DIVISION "K" and DIVISION "P";

Portion of North 1/2 of Southeast 1/4 of Section 10, Township 24 North, Range 5 East, lying southerly of existing Bellevue City Limits and westerly of the following described line: Beginning at a point on the south line of said north 1/2, 76 feet easterly of Southeast corner of Northwest 1/4 of Southeast 1/4 of said Section 10; thence running Northerly to a point on the old right-of-way margin of Primary State Highway No. 2, 50.4 feet easterly of the East line of said Northwest 1/4 of Southeast 1/4 of Section 10; Thence continuing on the Northerly production of aforescribed line to the existing Bellevue City Limits.

East 1/2 of Southeast 1/4 of said Section 22;

East 1/2 of Northeast 1/4 of Northeast 1/4 of Section 16, Township 24 North, Range 5 East.
