RESOLUTION NO. 1374

A RESOLUTION in regard to L.I.D. 65-S-87 for the construction of streets and sewers in the Cherry Crest area; and authorizing payment of draw to contractor and other miscellaneous expenses.

WHEREAS the City Council did on February 15, 1966, pass Ordinance No. 850 for the improvement of the Cherry Crest area by the construction and installation of streets and sewers, and did create Local Improvement District No. 65-S-87 therefor; and

WHEREAS said project has progressed and L.I.D. revenue warrants have previously been issued as follows:


AND WHEREAS it is necessary to issue L.I.D. warrants in payment thereof;


