## RESOLUTION NO. 1386

A RESOLUTION accepting a storm sewer easement from Campbell.

WHEREAS M. S. Campbell and Margaret Campbell have tendered to the City an easement for a storm drain pipeline over a portion of Lot 2, Pleasure Point Park No. 2, Unrecorded, and it is felt desirable to accept the same;

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Bellevue, Washington, as follows:

Section 1. That certain instrument, to-wit:

For valuable consideration, receipt of which is hereby acknowledged, the granter (s,

M. S. Campbell and Margaret Campbell

hereby grant and convey to the City of Bellevue, a municipal corporation of the State of Washington, grantee, its successors and assigns, an easement for a storm drain pipe line, upon and across a strip of land located in Bellevue, King County, Washington, to-wit:

The Northerly 10 feet of Lot 2, Pleasure Point Park No. 2, Unrecorded.

for the purpose of installing, constructing, maintaining, operating, repairing and replacing said storm drain pipe line and all necessary connections and appurtenances, together with the right of ingress and egress to, from and across said described property for the foregoing purposes. Provided, that upon the completion of the construction and installation of said storm drain pipe line, said easement shall cease and determine except as to a strip five (5) feet on either side of the center line of said storm drain pipe line; and provided further that upon the completion of the original installation of said storm drain pipe line, grantee shall immediately after such original installation restore said premises to their original condition as near as may be.

Grantor (s) shall make no use of the land in a manner to obstruct, clog, or interfere with the use herein granted.

The covenants herein contained shall run with the land and are binding upon all subsequent owners thereof.
