RESOLUTION NO. 1400

A RESOLUTION in regard to L.I.D. No. 66-SAN-91 for construction of sanitary sewers within an area generally described as bounded by 130th N.E., 140th N.E., Northrup Road and Bellevue-Redmond Road; and authorizing payment of draw to contractor and other miscellaneous expenses.

WHEREAS the City Council did on July 19, 1966 pass Ordinance No. 913 for the improvement of an area generally described as bounded by 130th N.E., 140th N.E., Northrup Road and Bellevue-Redmond Road, by the construction of sanitary sewers, and did create Local Improvement District 66-SAN-91 therefor; and

WHEREAS said project has progressed, and L.I.D. revenue warrants have previously been issued as follows:


