RESOLUTION NO. 2230

A RESOLUTION in regard to LID No. 161 for improvements within the area 100 feet on each side of the centerline of Northeast 8th Street between 100th Avenue Northeast and 108th Avenue Northeast, by the installation of underground electrical and telephone transmission lines, traffic and signal systems, sidewalks and landscaping; and authorizing the issuance of revenue warrants for payment of expenses for said improvements.

WHEREAS, the City Council did on the 27th day of March, 1972, pass Ordinance No. 1785 for improvement within the area 100 feet on each side of the centerline of Northeast 8th Street between 100th Avenue Northeast and 109th Avenue Northeast, by the installation of underground electrical and telephone transmission lines, traffic signal systems, sidewalks and landscaping, and did create Local Improvement District No. 161 therefore; and,

WHEREAS, a contract for the work has been let, the work has progressed and LID revenue warrants for this project have been previously issued as follows:
