RESOLUTION NO. 5387

A RESOLUTION authorizing execution of an amendment to the solid waste collection agreement between the City of Bellevue and Eastside Disposal Service for solid waste and yard waste collection service to allow for the pass through of a King County Health Department fee; and directing staff to submit an amendment to Chapter 5.20 of the Bellevue City Code for Council's review and approval.

WHEREAS, by Resolution No. 5071, the City Council approved an agreement with Eastside Disposal Service, a division of Rabanco Companies (Eastside) for solid waste collection services; and

WHEREAS, by Resolution No. 5139 and No. 5308, said agreement was amended; and

WHEREAS, pursuant to the King County Local Hazardous Waste Management Plan, adopted by the City of Bellevue on May 14, 1990 pursuant to Resolution No. 5266, the King County Health Department, which administers said Plan, passed an ordinance on April 2, 1991, imposing a fee of \$.60 per month on residential garbage accounts and \$5.23 per month on commercial accounts, beginning July 1, 1991, for a period of 30 months, to provide funds to reduce the amount of unregulated hazardous waste from households and small businesses; and

WHEREAS, it is necessary to adjust the solid waste collection rates currently in effect, pursuant to the agreement with Eastside, in order to accommodate the pass through of this temporary fee; and

WHEREAS, the City has the option to reallocate the cost between the two sectors of customers or within sectors, or both, as long as the dollar amount collected by the hauler adds up to the fee imposed by the King County Health Department; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The City Manager or his designee is hereby authorized and directed to execute on behalf of the City an amendment to the solid waste collection rates set forth in that certain agreement between the City and Eastside authorized pursuant to Resolution No. 5071, as amended by Resolution Nos. 5139 and 5308, a copy of which agreement has previously been given Clerk's Receiving No. 14445, for the purpose of increasing each

residential customer account by \$.60 per month and each commercial account by 1.64% for a period of 30 months beginning on July 1, 1991, in order to pass through the fee increase imposed by the King County Health Department; a copy of such rate amendment has been given Clerk's Receiving No. _/b5_73_. The increase in revenue provided to Eastside as a result of the rate increase authorized herein shall be exempt from the tax otherwise due and payable pursuant to B.C.C. 5.20.050.

Section 2. City staff is directed to prepare and submit to the City Council for its review and approval an amendment to B.C.C. 5.20.050 excluding certain "pass-through" charges, including but not limited to the charge set forth in Section 1 of this resolution, from application of the tax imposed by said section.
