

RESOLUTION NO. 61

A RESOLUTION granting consent to annex a portion of Sections 19, 20, 29 and 30 in Township 25 North, Range 5 East, W.M. and a portion of Sections 24, 25 and 36 in Township 25 North, Range 4 East, W.M. to Bellevue Sewer District.

THE CITY COUNCIL OF THE CITY OF BELLEVUE DO RESOLVE AS FOLLOWS:

Section 1. Consent is granted by the City Council of the City of Bellevue to the annexation to the Bellevue Sewer District of the following described land within the corporate limits of the City of Bellevue, to wit:

A portion of Sections 19, 20, 29 and 30 in Township 25 North, Range 5 East, W.M. and a portion of Sections 24, 25 and 36 in Township 25 North, Range 4 East, W.M. described as follows:

Beginning at the Southwest Corner of Section 30, Township 25 North, Range 5 East, W.M.; thence North along the West Boundary of Section 30 to the West  $\frac{1}{4}$  Corner of said Section; thence East along the North Boundary of the N.W.  $\frac{1}{4}$  of the S.W.  $\frac{1}{4}$  of Section 30 to the N.E. Corner of the N.W.  $\frac{1}{4}$  of the S.W.  $\frac{1}{4}$ ; thence North along the West boundary of the S.E.  $\frac{1}{4}$  of the N.W.  $\frac{1}{4}$  of Section 30 to the centerline of N.E. 20th Street; thence East along the centerline of N.E. 20th Street to the Centerline of 92nd Ave. N.E.; thence South along the Centerline of 92nd Ave. N.E. to the N.W. Corner of Lake Washington Garden Tracts; thence East along the North boundary of Lake Washington Garden Tracts to the centerline of 100th Ave. N.E.; thence continue East along the North boundary of Manor Hill Addition to the Northeast Corner of said addition; thence South along the East boundary of Manor Hill Addition to the Southwest corner of said addition; thence continue South on a straight line to the intersection of the centerlines of N.E. 10th St. and 102nd Ave. N.E.; thence East along the centerline of N.E. 10th Street and extension thereof to a point midway between the centerlines of 104th Ave. N.E. and 108th Ave. N.E.; thence North on a line midway between the centerlines of 104th Ave. N.E. and 108th Ave. N.E. to the South boundary of the Diamond S Ranch Subdivision; thence East along said South boundary to the centerline of 108th Ave. N.E.; thence North along the Centerline of 108th Ave. N.E. to the  $\frac{1}{4}$  Corner common to Sections 20 and 29 in Township 25 North, Range 5 East, W.M. thence on a straight line to the  $\frac{1}{4}$  Corner common to Sections 17 and 20 on the most southerly boundary of the City of Houghton; thence West along the North line of Section 20 and the South corporate boundary of Houghton to the Southwest corner of the corporate boundary of Houghton; thence North along the West corporate boundary of Houghton to the shore of Lake Washington; thence following the shore of Lake Washington to the point of beginning.
