

RESOLUTION 660

A RESOLUTION approving a petition to hold an election for the proposed annexation of portions of Sections 20, 21 and 28, Township 25, Range 5 E. W. M., King County Washington to the City of Bellevue.

WHEREAS, a petition for an election to vote upon the proposed annexation of a contiguous portion of King County to the City of Bellevue, signed by qualified voters resident in the area, equal in number to twenty per cent (20%) of the votes cast at the last election, has been filed with the City Council of the City of Bellevue; and

WHEREAS, the proposed action has been considered by the City Council as being conducive to the public advantage, benefit and welfare of the residents of the City of Bellevue and the area proposed to be annexed thereto; Now, therefore,

The CITY COUNCIL OF THE CITY OF BELLEVUE DO RESOLVE
AS FOLLOWS:

Section 1. That the City Council of the City of Bellevue does approve the action proposed in that petition filed with the City Council on the 28th day of June, 1955, seeking the setting of an election to be held among the qualified voters within the said area, to-wit:

Beginning at the northwest corner of Section 21, in Township 25, Range 5 E.W.M., thence east to the east line of Section 21, thence south on said east line to the south line of Section 21, thence south on the east line of Section 28 to the Bellevue city limit line on the center line of Northrup Way, thence westerly on the Bellevue city limit line and the center line of Northrup Way through Section 21 and into Section 20 to the intersection of Northrup Way and N.E. 33rd St., thence easterly on the Bellevue city limit line to the center line of 116th Ave. N. E., thence north on the center line of 116th Ave. and the Bellevue city limit line to the northwest corner of Section 21, the point of beginning.

on the question of annexation of said area to the City of Bellevue, Washington.

Section 2. That a copy of this resolution notifying the Board of Commissioners of King County of the approval by the City Council of the City of Bellevue to the proposed action be delivered to the said petitioners and the Board of County Commissioners of King County.
