RESOLUTION NO. 711

A RESOLUTION approving the completed preliminary planning report prepared with an advance from the United States of America under the terms of Public Law 560, 83rd Congress of the United States, approved August 2, 1954.

WHEREAS, the City of Bellevue, a municipal corporation of King County, Washington, accepted an offer from the United States Government for an advance for preliminary plan preparation of a public work described as Project Washington 45-P-3010, Storm Drainage System.

WHEREAS, R. W. Beck and Associates, utility analysts and engineers, was engaged to prepare a preliminary planning report for the aforesaid public work, and said architect and/or engineer has completed the report and submitted it for approval; and

WHEREAS, the completed preliminary planning report has been carefully studied and is considered to comprise adequate preliminary planning of the public work essential to the community and within the financial ability of the City of Bellevue, Washington, to construct;

NOW, THEREFORE, be it resolved by the City Council of the City of Bellevue, the governing body of said applicant, that the planning report submitted by R. W. Beck and Associates as the basis for detailed planning and construction of the above numbered storm drainage system dated October 7, 1957, in connection with Housing and Home Finance Agency Project No. 45-P-3010 be and the same is hereby approved; and that certified copies of this resolution be filed with the Housing and Home Finance Agency as a part of the preliminary planning report.
