CITY OF BELLEVUE, WASHINGTON

RESOLUTION NO. 724

A RESOLUTION of the City Council of the City of Bellevue, Washington, declaring its intention to order a local improvement for the construction of storm drainage sewers, catch basins and related improvements, setting forth the nature and territorial extent of the improvement, setting a date for hearing objections thereto, and providing for the giving of notice of such hearing.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, as follows:

Section 1. That it is the intention of the City Council to order the improvement of an area within the City included within the boundaries described in Exhibit "A" attached hereto and by this reference incorporated herein and made a part hereof.

Section 2. That said improvement shall consist of trunk drain lines, laterals, catch basins and related improvements to be constructed and installed as set forth in Exhibit "B" attached hereto and by this reference incorporated herein and made a part thereof. The routes along which the trunk sewer, subsewer and branches of laterals are to be constructed are set forth in said Exhibit "B."

Section 3. That all persons who may desire to object thereto are hereby notified to appear and present such objections at a meeting of the City Council, or a Committee thereof, to be held in the Council Chambers in the City Hall (V. F. W. Building), Main Street at 100th Avenue Southeast, in the City of Bellevue at \$\frac{100}{200}\ o^*\text{clock p.m.}, on the \$\frac{100}{200}\ day of \$\frac{5eptember}{200}\ day of \$\frac{5eptembe

Section 4. That the City Manager and City Engineer shall submit to the City Council at or prior to said date all data and information required by law to be submitted.



Section 5. That the cost and expense of said improvement shall be born by and assessed against the property liable therefor as provided by law.

S. Hendrickson County Road No. 1195 with the center line of 114th Avenue S.E.; thence southeasterly along said center line of H. S. Hendrickson County Road No. 1195 to an intersection with the center line of the abandoned channel of Mercer Slough; thence easterly along the center line of the abandoned channel of Mercer Slough to an intersection with the center line of the right-of-way of Drainage District No. 12; thence southerly along said center line of said right-of-way to an intersection with a line parallel to the north-south center line of Section 9, Township 24 North, Range 5 East, W.M.; which parallel line lies 2,686.7 feet west from the center of said Section 9 (as measured along the east-west center line of said Section 9); thence leaving the Bellevue city limit continuing southerly along the center line of right-of-way of said Drainage District No. 12 to an intersection with a line parallel to the east-west center line of said Section 9 which parallel line lies 217-1/8 feet south from a point on the south margin of H. S. Hendrickson County Road No. 1195 (as measured along a line parallel to the north-south center line of said Section 9) and which point on the south margin

of H. S. Hendrickson County Road No. 1195 lies 2,686.7 feet west from the north-south center line of said Section 9 (as measured along a line parallel to the east-west center line of said Section 9); thence following the Bellevue city limit continuing southerly along the center line of right-ofway of said Drainage District No. 12 to an intersection with the easterly production of the center line of Donald Street as originally dedicated and laid out; thence northwesterly along said center line of Donald Street to the intersection with the center line of Nathan Beeman County Road No. 1274; thence westerly along the center line of Nathan Beeman County Road No. 1274 to an intersection with the center line of 108th Avenue S.E.; thence north along the center line of 108th Avenue S.E. to a point on the north line of Beaux Arts Village (unrecorded), said point being approximately 922.68 feet south from the north one-quarter corner of Section 8, Township 24 North, Range 5 East, W.M.; thence west along the north line of Beaux Arts Village to an intersection with the shoreline of Lake Washington; thence northerly along the shoreline of Lake Washington to an intersection with the center line of S.E. 15th Street; thence east along the center line of S.E. 15th Street to an intersection with the center line of A.S. Cragin Road No. 1571 (S.E. 5th Street at this point) with the center line of 99th Avenue S.E.; thence northeasterly to the southeast corner of Lot 50, Shorelands, as recorded in Volume 33 of Plats, Page 8, records of King County, Washington; thence northerly along the east boundary of said Lot 50 to an intersection with the shoreline of Lake Washington (Meydenbauer Bay); thence starting in an easterly direction and continuing along the shoreline of Lake Washington to an intersection with the southeasterly boundary of Lot 14, Block 26, Kenwood Park, as recorded in Volume 8 of Plats, Page 26, records of King County, Washington; thence northeasterly along the southeasterly line of said Lot 14 and along the northerly production of said southeasterly line to an intersection with the southerly production of the center line of vacated 90th Avenue N.E.; thence northerly along said southerly production, along said center line of 90th Avenue N.E., and along the northerly production of said center line to an intersection with the center line of N.E. Lake Washington Boulevard; thence northwesterly along the center line of N.E. Lake Washington Boulevard to an intersection with a line perpendicular thereto when such line is drawn from the point of intersection of the southwesterly margin of N.E. Lake Washington Boulevard with the northeasterly margin of Overlake Drive East (also known as M. F. Wright Road); thence southwesterly along said perpendicular line to the intersection of the southwesterly margin of N.E. Lake Washington Boulevard with the northeasterly margin of Overlake Drive East; thence leaving the Bellevue city limit northwesterly along the southwesterly margin of N.E. Lake Washington Boulevard to an intersection with the Bellevue city limit line drawn from a point on the west boundary of Tract 7 Eastland Acre Tracts Supplemental, as recorded in Volume 10 of Plats, Page 20, records of King County, Washington, 280.13 feet south from the south margin of N.E. 10th Street, which line bears northeasterly at an angle of 77 degrees 42 minutes 09 seconds from said west boundary of said Tract 7; thence following the Bellevue city limit northeasterly along said line to an intersection with the center line of N.E. Lake Washington Boulevard; thence northwesterly along the center line of N.E. Lake Washington Boulevard to an intersection with the center line of N.E. 10th Street; thence east along the center line of N.E. 10th Street to an intersection with the east boundary of Eastland Acre Tracts Supplemental; thence northerly along the east boundary of Eastland Acre Tracts Supplemental and along the east boundary of Hillandale Addition, as recorded in Volume 49 of Plats, Pages 94 and 95, records of King County, Washington, to the northeast corner of said Hillandale Addition; thence easterly along the north boundary of the south one-half of the south one-half of Section 30, Township 25 North, Range 5 East, W.M. to an intersection with the west boundary of Lot 8, Block 2, Cherry Hill Addition, as recorded in Volume 50 of Plats, Page 47, records of King County, Washington; thence northerly along the west boundary of said

Lot 8 to the northwest corner thereof; thence easterly along the north boundary of said Lot 8 to an intersection with the southerly production of the center line of 98th Avenue N.E.; thence northerly along the center line of 98th Avenue N.E. to an intersection with the center line of N.E. 14th Street; thence easterly to an intersection with the southerly production of the west line of Lot 14, Cascade Peak, as recorded in Volume 43 of Plats, Page 39, records of King County, Washington; thence northerly along the southerly production of said west line and along said west line to the southwest corner of Lot 7, Cascade Peak; thence northerly along the west boundary of said Lot 7 to the northwest corner thereof; thence easterly along the north boundary of said Lot 7 to an intersection with the east boundary of Lot 3, Lake Washington Garden Tracts, as recorded in Volume 9 of Plats, Page 11, records of King County, Washington; thence northerly along the east boundary of said Lot 3 to the northeast corner thereof; thence easterly along the north boundary of said Lake Washington Garden Tracts to an intersection with the center line of 98th Avenue N.E.; thence northerly along the center line of 98th Avenue N.E. and the northerly production thereof to an intersection with the center line of Lake Washington Boulevard; thence northeasterly along the center line of Lake Washington Boulevard to an intersection with the center line of N.E. Northup Way; thence southeasterly along N.E. Northup Way to an intersection with the east boundary of Northup's Acre Tracts, as recorded in Volume 6 of Plats, Page 45, records of King County, Washington; thence southerly along the east boundary of Northup's acre Tracts to the south boundary of the southeast quarter of the northwest quarter of Section 20, Township 25 North, Range 5 East, W.M.; thence east 177.5 feet; thence north 955 feet; thence west 45.5 feet; thence north 365 feet to an intersection with the north boundary of the southeast quarter of the northwest quarter of said Section 20; thence east along the north boundary of the southeast quarter of the northwest quarter of said Section 20 to an intersection with the west boundary of the northeast quarter of said Section 20; thence leaving the Bellevue city limit northeasterly to the southwest corner of the northeast quarter of the northwest quarter of the northeast quarter of Section 20, Township 25 North, Range 5 East, W.M.; thence east along the south boundary of the north one-quarter of the northeast quarter of said Section 20 to the southwest corner of the northeast quarter of the northeast quarter of the northeast quarter of said Section 20; thence north along the west boundary of the northeast quarter of the northeast quarter of the northeast quarter of said Section 20 to an intersection with the north line of said Section 20 (the Bellevue city limit); thence following the Bellevue city limit east along the north line of said Section 20 to the northeast corner thereof; thence south along the east line of said Section 20 to the east-west center line of said Section 20; thence west on said east-west center line to an intersection with the N.P.R.R. right-of-way line; thence northwesterly on said right-of-way line for a distance of 355 feet, more or less; thence west 134 feet to the east line of the N.P.R.R. rightof-way; thence southwesterly to the N.P.R.R. P.T. Station 518 - 46.7 feet; thence northwesterly on the west line of the N.P.R.R. right-of-way 220 feet, more or less; thence South 43 degrees 13 minutes West 332.80 feet to the north margin of N.E. 33rd Place; thence westerly along said north margin a distance of 502 feet, more or less; thence North 71 degrees 54 minutes West 253.10 feet, more or less; thence South 00 degrees 18 minutes 24 seconds West to the center line of N.E. Northup Way; thence southeasterly along the center line of N.E. Northup Way; thence southeasterly along the center line of N.E. Northup Way to an intersection with the east line of said Section 28; thence southerly along the east line of said Section 28 to an intersection with the center line of N.E. Redmond-Bellevue Road; thence southwesterly along the center line of N.E. Redmond-Bellevue Road to an intersection with the northly production of the east boundary of the west one-half of the northwest quarter of Section 33, Township 25 North, Range 5 East, W.M.; thence southerly along the northerly production of the east boundary of the west one-half of the northwest quarter of said Section 33 and along said east boundary to the northeast corner of the south one-half of the southwest quarter of the northwest quarter of said Section 33; thence westerly to the northwest corner of the south one-half of the southwest quarter of the northwest quarter of said Section 33, which point lies on the center line of 116th Avenue N.E. (formerly Secondary State Highway No. 2A); thence southerly along the center line of former Secondary State Highway No. 2A to an intersection with the south boundary of Township 25 North, Range 5 East, W.M.; thence west along the south boundary of Township 25 North to the point of beginning.

EXCEPT: Beginning at the north quarter corner of Section 8, Township 24, Range 5, EWM, King County, Washington; thence east along the north section line of said section to its intersection with the west boundary of Lot 15, Block 1 of Bel-Forest Addition No. 1, which is the true point of beginning; thence east along said north section line to its intersection with the east boundary of Lot 16, Block 1 of Bel-Forest Addition No. 1; thence south along said east boundary to its intersection with the center line of S.E. 24th Place, a duly laid out and dedicated street; thence east along said center line of S.E. 24th Place to its intersection with the extended eastern boundary of Lot 7, Block 4 of Bel-Forest Addition No. 1; thence south along said east boundary to the intersection with the north boundary of Lot 5, Block 4 of Bel-Forest Addition Division No. 1, as recorded in Volume 46 of Plats, Pages 73 and 74, records of King County, Washington; thence east along the north boundary to its intersection with the east boundary of Bel-Forest Addition Division No. 1; thence south along said east boundary to its intersection with the south boundary of Bel-Forest Addition No. 1; thence easterly to its intersection with the west boundary of Lot 1 of Bellevue Realty Addition No. 2, as recorded in Volume 53 of Plats, Page 98, records of King County, Washington; thence south along said west boundary to its intersection with the center line of S.E. 27th Place; thence east along said center line to its intersection with the extension of the west boundary of Lot 12, Bellevue Realty Addition No. 2; thence south along said boundary to its intersection with the north boundary of Brennan's Enatai Gardens No. 2, as recorded in Volume 55 of Plats, Page 7, records of King County, Washington; thence east along said boundary to its intersection with the west boundary of Lot 5 of Brennan's Enatai Gardens No. 2; thence south along said west boundary and the extension of said boundary to its intersection with the south boundary of Brennan's Enatai Gardens No. 2; thence east along said south boundary to its intersection with the extension of the east boundary of Lot 6 Beaumont Park Addition to the City of Bellevue, as recorded in Volume 54 of Plats, Page 14, records of King County, Washington; thence south along said extension of the east boundary of Lot 6 Beaumont Park Addition to the City of Bellevue to its intersection with the center line of S.E. 30th Place; thence west along said center line to a point of intersection of the extension of the east boundary of Lot 16 Beaumont Park Addition to the City of Bellevue; thence south along said east boundary line to its intersection with the south boundary of Beaumont Park Addition to the City of Bellevue; thence west along said southern boundary to its intersection with the east boundary of Lot 6 Failor's Enatai Gardens No. 3, as recorded in Volume 47 of Plats, Page 52, records of King County, Washington; thence south along said east boundary and (its extension) to its intersection with the north boundary of Holly Hill, as recorded in Volume 53 of Plats, Page 56, records of King County, Washington; thence east along said north boundary to its intersection with east boundary of Lot 5, Block A, Holly Hill; thence south along said east boundary and (its extension) to its intersection with the north boundary of Lot 6, Block B, Holly Hill; thence west along said north boundary to its intersection with the east boundary of Lot 5, Block B, Holly Hill. Thence south along said east boundary and (its extension) to its intersection with the center line of S.E. 34th; thence northwesterly on said center line to its intersection with the extension of the west boundary of Lot 17, Block 1, Failor's Enatai Gardens, as recorded in Volume 43 of Plats, Page 32, records of King County, Washington; thence north along said west boundary (and its extension) to its intersection with the center line of S.E. 31st Street. Thence west along said center line to its intersection with the center line of 108th N.E.; thence north along said center line to its intersection with the north boundary of Lot 1, Block 1, Bel-Forest Addition Division No. 1; thence east along said north boundary to its intersection with the west boundary of Lot 15, Bel-Forest Addition Division No. 1; thence north along said west boundary to the true point of beginning.
