A RESOLUTION initiating vacation of a portion of 109th Ave NE south of NE 10th Street and setting a time and place for a hearing to consider such a vacation.

WHEREAS, the City Council received a petition to initiate the vacation of a certain City right-of-way set forth in Section 1 herein and desires to set a time and place for a hearing before the City Council to consider such vacation; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The City Council hereby initiates the vacation, pursuant to section 14.35.030 of the Bellevue City Code, of the following City right-of-way:

A portion of 109th Ave NE south of NE 10th Street, more particularly described in Exhibit A attached hereto and by this reference incorporated herein.

Section 2. A public hearing shall be held upon the proposal to vacate the City right-of-way set forth in Section 1 on Monday, November 7, 2005 at the hour of 6:00 p.m. or as soon thereafter as the matter may be heard by the City Council, in the Council Chambers at the Municipal Building, 11511 Main Street, Bellevue, Washington.

Section 3. Notice of such hearing shall be provided and posted in the manner required by sections 14.35.050 and 14.35.060 of the Bellevue City code inviting interested persons to appear and be heard for or against the proposed vacation.

Section 4. This matter is referred to the City Manager or his designee for investigation and report, as necessary, at said public hearing.

RIGHT OF WAY VACATION

That portion of 109th Avenue Northeast in the Southwest Quarter of the Southeast Quarter in Section 29, Township 25 North, Range 5 East in the City of Bellevue, King County, Washington described as follows:
