RESOLUTION NO. 7331

A RESOLUTION canceling city warrants not presented for payment within one year of issuance and directing the transfer of all records of such warrants.

WHEREAS, RCW 39.56.040 requires that all city warrants not presented within one year of their issue, shall be canceled by passage of a resolution of the governing body of the municipal corporation; and

WHEREAS, upon notice of the passage of such resolution the treasurer of the municipal corporation shall transfer all records of such warrants so as to leave the funds as if such warrants had never been drawn; and

WHEREAS, the City Council desires to cancel all city warrants issued during the period January 1, 2004 through December 31, 2004 that have not been presented for payment on or before December 31, 2005: now, therefore,


