

CITY OF BELLEVUE, WASHINGTON

RESOLUTION NO. 753

A RESOLUTION, defining the existing future street pattern lying within an area bounded by Main and Northeast 12th Streets and 100th and 120th Avenues Northeast; extending same to include 104th Avenue Southeast between Main Street and Southeast 8th Street; and amending Resolution No. 723.

WHEREAS, the City Council did on January 14, 1958, pass Resolution No. 723 in which it defined the existing future street pattern as to location and future street width, including an extension eastward; and

WHEREAS, the Planning Commission has recommended to the Council that the official future street width plan be amended by adding thereto 104th Avenue Southeast, from Main Street to Southeast 8th Street, said street to have a future width of 80 feet; and

WHEREAS, the City Council has heard and considered the matter together with opinions and recommendations of the Planning Commission; now therefore,

BE IT RESOLVED by the City Council of the City of Bellevue, Washington, as follows:

Section 1. That the existing future street pattern is defined as to location and future street width as follows:

100th Avenue, N.E. and 104th Avenue, N.E. from Main Street to N.E. 12th Street as 100 feet wide,
102nd Avenue, N.E. from Main Street to N.E. 4th Street as 80 feet wide,
102nd Avenue, N.E. from N.E. 8th Street to N.E. 12th Street as 80 feet wide,
106th Avenue, N.E. from Main Street to N.E. 12th Street as 80 feet wide,
108th Avenue, N.E. from Main Street to N.E. 8th Street as 100 feet wide,
Main, N.E. 4th, N.E. 8th and N.E. 12th Streets from 100th to 108th Avenues, N.E. as 100 feet wide,
N.E. 1st Street from 100th to 104th Avenues, N.E. as 80 feet wide,
N.E. 2nd and N.E. 6th Streets from 104th to 108th Avenues, N.E. as 80 feet wide,
N.E. 10th Street from 100th to 106th Avenues, N.E. as 80 feet wide,
110th Avenue, N.E. from Main Street to N.E. 8th Street as 80 feet wide,
112th Avenue, N.E. from Main Street to N.E. 12th Street as 100 feet wide,

Main Street from 108th to 116th Avenues as 100 feet wide,
N.E. 2nd and N.E. 6th Streets from 108th to 112th Avenues, N.E. as 80 feet wide,
N.E. 4th and N.E. 12th Streets from 108th to 112th Avenues, N.E. as 100 feet wide,
N.E. 8th Street from 108th to 120th Avenues, N.E. as 100 feet wide.

Section 2. That this existing future street pattern, as set forth above in Section 1, be extended southward to include:

104th Avenue S.E., from Main Street to S.E. 8th Street as 80 feet wide.
