

CITY OF BELLEVUE, WASHINGTON

RESOLUTION NO. 950A

A RESOLUTION regarding the annexation of contiguous unincorporated territory north of the Sunset Highway, and amending Resolution No. 950.

WHEREAS the City Council of the City of Bellevue did on July 24, 1962 pass Resolution No. 950; and

WHEREAS the seventh line of Section 1 of said Resolution contained an error in that it read as follows:

"(Northrup Rd. #143); thence easterly along said centerline to"

when it should have read as follows:

"(Northrup Rd. #1431); thence easterly along said centerline to"

AND WHEREAS the City Council is desirous of making the necessary correction; now therefore

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. Section 1 of Resolution No. 950 passed by the City Council on July 24, 1962 is hereby amended to read as follows:

Section 1. The City Council does hereby determine that the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory which is contiguous to the City of Bellevue:

Beginning at the intersection of the west line of Section 27, Twp. 25 N, R 5 E., W.M., and the center line of NE 20th St. (Northrup Rd. #1431); thence easterly along said centerline to the north-south center section line of said Section 27; thence northerly along said center section line to its intersection with the center line of NE 21st St. (Howard Rd. No. 940); thence easterly along said center line to its intersection with the center line of Co. Rd. No. 966 (NE 20th St.); thence continuing easterly along the center line of said Co. Rd. No. 966 to its intersection with the Redmond-Bellevue Rd. No. 966; thence north-easterly along the center line of said Redmond-Bellevue Rd. to its intersection with the center line of NE 30th St.; thence easterly along the center line of said NE 30th St. to its intersection with the north-south center section line of Section 24; thence southerly along said center section line to the north line of Section 25; thence continuing southerly along the north-south center section line of said Section 25 to the north line of Section 36; thence easterly along the north line of said Section 36 to the north west corner of Section 31, Twp. 25 N, R 6 E., W.M.; thence continuing easterly along the north line of said Section 31 and along the easterly extension of the north line of said Section 31 to its intersection with the north-south center line of Lake Sammamish;

thence southerly along the center line of said Lake Sammamish to its intersection with the easterly extension of the south line of Section 36, Twp. 25 N, R 5 E., W.M.; thence westerly along the easterly extension of the south line and along the south line of said Section 36 to the east line of the west 1/4 of the west 1/4 of Section 1, Twp. 24 N, R 5 E., W.M.; thence southerly along said east line to the north line of Section 12, Twp. 24 N, R 5 E., W.M.; thence continuing southerly along the east line of the west 1/4 of the west 1/4 of said Section 12, to the south east corner of the north west 1/4 of the north west 1/4 of said Section 12; thence westerly along the south line of said north west 1/4 to the east line of Section 11, Twp. 24 N, R 5 E, W.M.; thence southerly along said east line to its intersection with the center line of SE 34th St.; thence south westerly along the center line of said SE 34th St. to its intersection with the center line of County Rd. No. 111; thence south easterly along the center line of said County Rd. No. 111 to the east line of Section 11, Twp. 24 N, R 5 E., W.M.; thence southerly along the east line of said Section 11 to northerly margin of the right of way of Primary State Highway No. 2; thence westerly along said northerly margin of the right of way of said Primary State Highway No. 2 to its intersection with the easterly City limits of the City of Bellevue; thence northerly following the said easterly City Limits as defined in the City of Bellevue Incorporation and as revised in City of Bellevue Ordinances numbered 213, 205, 368, 207, 333, 331, 332 and 369, to the true point of beginning.

Section 2. That a certified copy of this resolution be filed with the Board of County Commissioners of King County, Washington, in which county said territory is located.
