RESOLUTION NO. 966

A RESOLUTION regarding the annexation of contiguous unincorporated territory, which territory is south of the Sunset Highway.

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The City Council does hereby determine that the best interests and general welfare of the City of Bellevue would be served by the annexation of the following-described unincorporated territory which is contiguous to the City of Bellevue:

Beginning at the intersection of the southerly limit of the right of way of Primary State Highway No. 2 and the east line of the west half of the west half of Section 10, Twsp. 24 N, Range 5 E, W.M.; thence southerly along said east line to the north line of Section 15, Twsp. 24 N, R 5 E, W.M.; thence continuing southerly along the east line of the west half of the west half of said Section 15 to a point lying 120 feet southerly of the southerly right of way margin of SE 40th Street; thence easterly 120 feet southerly of and parallel to the southerly right of way margin of said SE 40th Street to west line of the Plat of Eastview Homes as recorded in Volume 53, Page 39, of Plats, Records of King County, Washington; thence northerly along the west line of said plat to the centerline of SE 40th Street; thence easterly along the centerline of said SE 40th Street to the north-south center section line of said Section 15; thence southerly along said north-south center section line to the centerline of the Newport-Issaquah Road No. 941; thence easterly along the centerline of said Newport-Issaquah Road to the west line of the east half of the east half of said Section 15; thence southerly along the said west line to the east-west center section line of said Section 15; thence easterly along the said center section line to the east line of said Section 15; thence southerly along the said east line to the north east corner of Section 22, Twsp. 24 N, R 5 E, W.M.; thence westerly along the north line of said Section 22 to the west line of the east half of the east half of said Section 22; thence southerly along the said west line to the east-west center section line of said Section 22; thence easterly along the said east-west center section line to the east line of said Section 22; thence southerly along the said east line to the south line of said Section 22; thence westerly along the south line of said Section 22 to the south-east corner of Section 21, Twsp. 24 N, R 5 E, W.M.; thence continuing westerly along the south line of said Section 21 to the north-south center section line of said Section 21; thence northerly along the said north-south center section line to the south line of the north half of the south half of said Section 21; thence westerly along the said south line to the east line of Section 20, Twsp. 24 N, R 5 E, W.M.; thence continuing westerly along the south line of the north half of the south half of said Section 20 and its westerly extension to the Inner Harbor line of Lake Washington; thence northerly along the said Inner Harbor line to the south line

of the City of Bellevue, Washington, as defined in the City of Bellevue Ordinances 397 and 416; thence easterly and northerly along the south and east lines of the City of Bellevue as defined in the City of Bellevue Ordinances 397, 416, 223 and 213 to the southerly limit of the right of way of Primary State Highway No. 2; thence easterly along the said southerly limit of Primary State Highway No. 2 to the point of beginning. All in King County, Washington.


Section 2. That, as nearly as may be, the number of voters residing in the aforesaid territory is 2208.

Section 3. The City Council does hereby pray that the Board of County Commissioners of King County, Washington, call an election to be held among the qualified voters in the aforesaid territory upon the question of annexation.


Section 4. That the cost of said annexation election shall be paid by the City of Bellevue.

Section 5. That a certified copy of this resolution be filed with the Board of County Commissioners of King County, Washington, in which county said territory is located.
